WHEREAS, said application for exemption from audit has been completed in accordance with regulations issued by the state auditor.





WHEREAS, neither revenues nor expenditures exceeded \$750,000 for fiscal year 2022;


WHEREAS, an application for exemption form audit has been prepared by a person familiar with governmental accounting; and
